The Farm Engagement Program helps organic cotton producers gain access to sustainable textile and apparel markets and links them to Textile Exchange's large network of brands, retailers and manufacturers seeking organic cotton.

Knowledge & Information

- **Farm Hub** – Our new website provides extensive learning material on organic cotton, document library, a farmer visibility tool: Find a Producer, and much more.

- **Farm and Fiber Report** – The Farm Engagement team produces the annual Farm and Fiber Report; the definitive source of information on global organic cotton fiber production and use.
- **Engage** – the monthly Engage Newsletter (in three languages) provides up to date news and views on organic cotton farming around the world and interviews with a wide range of organic cotton stakeholders.
